Claire Gahm is a Pediatric Emergency Medicine, Global Health and EMS physician at Children's Hospital Colorado in Aurora, Colorado. She is the Associate Medical Director of EMS at Children's Colorado as well as the Pediatric Medical Director of Aurora Fire Rescue. During her EMS fellowship in San Diego, she worked as the Associate Medical Director for the SDFD paramedic program which sparked her passion for EMS outreach and education. She completed her MPH degree with a focus on community public health and systems development while serving for a year as an Emergency Medical Services for Children Innovation and Improvement Center (EMSC-EIIC) Fellow with a focus on pediatric disaster preparedness. She also recently served as the community health domain lead for the ASPR Center of Excellence pediatric disaster preparedness grant for the Gulf region. Her interests include pediatric advocacy, paramedic education, disaster preparedness and global EMS system development.

Dr. Ed Racht

Dr. Ed Racht is the Chief Medical Officer of Global Medical Response, the largest Air & Ground EMS provider in the nation. He has been involved in Emergency Medical Services and healthcare systems for more than 35 years. Prior to his current position, Racht served as the Chief Medical Officer and Vice President of Medical Affairs for Piedmont Newnan Hospital in Georgia. Racht was the first full-time Medical Director for the Austin/Travis County Emergency Medical Services System, where he spent 13 years from 1995-2008. The System was nationally recognized in the Institute of Medicine's Report on the state of emergency care for its collaborative approach to challenging healthcare integration issues. Racht is the recipient of numerous awards including being named EMS Medical Director of the year for the State of Texas, the American Heart Association's Paul Ledbetter MD Physician Volunteer of the Year Award, and being named a "Hero of Emergency Medicine" by the American College of Emergency Physicians. In 2015, he was the first recipient of the Joseph P. Ornato Excellence in Clinical Leadership Award and in 2011 received the Slovis Award for Educational Excellence by the US Metropolitan Municipalities Medical Director Consortium. In his early years, Racht was featured in a cover article in JEMS magazine on the "New Breed of Medical Directors". He is also the third Inductee in the Texas EMS, Trauma and Acute Care Foundation Hall of Fame. Racht has three adult children who still remind him every day what his mother taught him years ago. "One day honey, you'll have kids of your own. You'll see..."
