### **Description**

The Billings Clinic Grand Rounds Lecture Series provides a forum for multidisciplinary and interprofessional discussion of challenges faced by our medical staff in providing evidenced based care for our patients. Content is geared toward an audience consisting mainly of physicians and nonphysician providers. However, the series is open to all Billings Clinic employees and the local health care community. Depending on content, administrative, and other staff may attend. This course consists of formal lectures and case presentations. To facilitate group learning and promote interprofessional teams, we encourage alternative presentations formats, including 2-3 shorter case presentations by different individuals and more interactive design. The focus is to have broad representation of all departments within the organization. The option of receiving CME credit is available to these sites. Billings Clinic is has switched to a virtual presentation environment which has enabled a wider audience to participate in Grand Rounds activities.

- 2 Apply information on more time-efficient and cost-efficient methods for treating patients including professional leadership in healthcare and faculty development.
