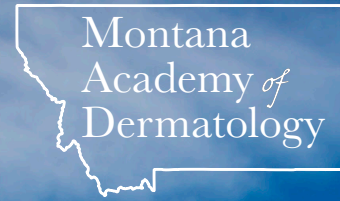

## Conference Description:

This conference is designed to provide dermatologists, dermatopathologists, and other health care professionals interested in dermatology with the most current information. Clinical topics will include Staph aureus, pityriasis rubra pilaris, melanoma, alopecia management, hidradenitis suppurativa, and more. Updates, case studies, and clinical strategies for patient evaluation and management in these areas will be presented in an informal atmosphere that facilitates audience participation and discussion.

## Course Objectives:

1. Demonstrate increased competence in identifying a variety of dermatologic ailments, such as management of melanoma, alopecia, and hidradenitis suppurativa.
2. Discuss the appropriateness of skin biopsies, targeted therapies, differential diagnosis, and the importance of appropriate genetic testing.

## Conference Faculty

**Julia Curtis, MD**  
Dr. Julia Curtis is a Board-certified dermatologist in the Department of Dermatology at the University of Utah. She is Director of the Mole Mapping Program at the Midvalley Health Center and a fellow in the American Academy of Dermatology. She has a clinical interest in pigmented lesions, early diagnosis of skin cancers with dermoscopy and in vivo cutaneous imaging, and Stevens-Johnson and Toxic Epidermal Necrolysis syndromes. Dr. Curtis also shares in the supervision of the inpatient dermatology consultation services at the University of Utah and Huntsman Hospitals.

**Ronda Farah, MD**  
Dr. Ronda Farah graduated from the University of Minnesota College of Biological Sciences before attending medical school at the University of Minnesota Medical School. Dr. Farah completed her internship year at the Hennepin County Medical Center before venturing to the University of Iowa Hospitals and Clinics for her Dermatology residency. Following residency, Dr. Farah served as a fellow at the University of Minnesota, which included a collaboration with Dr. Ross Anderson and the Wellman Center for Photomedicine in Boston, MA and Dr. Neil Sadick at Sadick Dermatology in New York, NY.

While in fellowship, Dr. Farah began serving as a staff physician at the University of Minnesota Medical Center, Director of Medical Dermatology at M Health Maple Grove Clinics, and Director at Cosmetic Dermatology in Minnesota. During this time, she was also an assistant professor for the University of Minnesota Medical School and a co-supervisor for the Dermatology Interest Group at the University of Minnesota - Twin Cities Dermatology. In 2016, she became the health cosmetic lead at the University of Minnesota before becoming a supervisor of intern and dermatology research fellows at the University of Minnesota and, more recently, a faculty advisor for Masters of Biological Sciences students at the University of Minnesota. Dr. Farah also serves as a staff dermatologist for the Minneapolis Veterans Affairs Health Care System.

**Sancy Leachman, MD, PhD**  
Sancy Leachman, M.D., PhD., is a physician-scientist who chairs the Department of Dermatology at Oregon Health & Science University (OHSU) and is the director of the Melanoma Research Program at the OHSU Knight Cancer Institute, an NCI-designated Comprehensive Cancer Center. Dr. Leachman started her journey with a BA from the University of Texas at Austin Plan II before completing her medical degree at the University of Texas Southwestern School of Medicine. Dr. Leachman completed her residency at Yale - New Haven Hospital and a fellowship from Yale University School of Medicine, where she focused in cutaneous oncology. Prior to joining OHSU in 2013, Dr. Leachman was at the University of Utah, where she was director of the Melanoma and Cutaneous Oncology Program in the Huntsman Cancer Institute, a professor in the Department of Dermatology, and member of the Imaging,

Diagnostics, and Therapeutics Program and the Cancer Control and Population Sciences Program. Leachman was a key figure in developing the Melanoma and Cutaneous Oncology Program at Huntsman Cancer Institute.

**Jamie Rhoads, MD**  
Dr. Jamie Rhoads graduated from Florida State University where she majored in Chemistry and Biochemistry with minors in biology and math followed by medical school at the University of Florida College of Medicine. Her intern year was spent at the University of Florida College of Medicine in Jacksonville. After internship, Dr. Rhoads spent time as a research fellow with the University of Utah, where she also completed her dermatology residency. Dr. Rhoads has specialized interest in medical dermatology and infectious disease dermatology. She has completed a two-year fellowship in psoriasis and published research in this area. She enjoys caring for patients with any general dermatologic concerns.

**Scott Worswick, MD, FAAD**  
Dr. Scott Worswick received his BA from Princeton before attending medical school at USC Keck School of Medicine. Dr. Worswick spent internship year at California Pacific Medical Center in San Francisco before completing his residency at Dermatology at David Geffen School of Medicine at UCLA. Dr. Worswick is in his sixth year as an associate professor of dermatology at USC and ninth year as the director of inpatient dermatology (the first half of this time being spent while previously on faculty at UCLA). While at UCLA, Dr. Worswick served as the associate residency program director and has had the privilege of being co-program director with Dr. Ashley Crew.
